Dear Dr. Bettes,

I hope your trip to London was productive and enjoyable. When we spoke on the phone before your flight, you indicated you would return today, Thursday, September 26, and we would resume our conversation about counseling tomorrow, September 27, 2013.

Before we get started down the path of treatment, my attorney wanted to remind you, my personal physician and me that the Company has not been following the contract. For example, the necessity of me seeing a psychiatrist in the first place was not clearly established. There was a requirement under Section 15.G.2.a of our Collective Bargaining Agreement (see attached) that required you to consult with my physician, Dr. Mark Nugent, prior to the evaluation in Houston with Dr. Glass. That did not happen and since I did not want to be accused of insubordination by the Company, I attended the evaluation and cooperated fully.

In the present time, we should consider that the same section of the contract applies to treatment. Your decision to seek counseling for me logically falls under "treatment" in the CBA. I am still not sure what I am being treated for since the origin of these medical procedures is based on me filing security concerns with the Company. The Company has never provided the "reasonable basis" for these examinations to either you or me, even after they dropped their theory that I had allegedly experienced a Temporary Ischemic Attack (TIA).

As I have stated in the past, I consider the Company's initiation of these procedures to be a violation of Federal law. But if I am wrong, we should at least be following the procedures of Section 15.G.2.b which requires you to consult with Dr. Nugent as to whether or not counseling is appropriate at this point. In the event that you and Dr. Nugent cannot agree that the evaluation and treatment are inappropriate in this case, there is a mechanism in the language that triggers a third doctor's opinion. I refer you to the attached copy of Section 15 of our CBA.
